## 2. General Remarks:

Akiki Frères offers a broad range of fruit and vegetables for retailers and wholesalers. Deliveries come by container from overseas (e.g. Brasilia), by aircraft from Europe, or by truck from Lebanon. The produce is stored under good hygiene conditions and undergoes daily visual checks. A quality management system does not exist. Great value is set upon fresh produce which could be proved during the audit.

## 3. Audit findings:

No deficiencies were identified.

## 4. Assessment:

The company is kept clean and tidy. Close control is carried out by the qualified personnel.

Therefore, Akiki Frères Fruits is a suitable supplier for the Bundeswehr.
